Terms & Conditions – GLENARM CASTLE X 2024 BALMORAL SHOW COMPETITION

1. The Promoter is: Royal Ulster Agricultural Society, whose registered office is at Eikon Exhibition Centre, Halftown Road, Belfast, BT27 5RD.
2. By entering, participants will be deemed to have accepted and be bound by the Terms and Conditions. All entry instructions form part of these Terms and Conditions.
3. The competition is open to NI residents aged 18 years and over, except employees of the Royal Ulster Agricultural Society, Glenarm Castle, NFU Mutual, their families or agents, or anyone professionally connected with the promotion.
4. The *Glenarm Castle X 2024 Balmoral Show* Competition will be run on the official Balmoral Show Facebook and Instagram pages. Multiple entries per person are permitted.

To enter on Facebook participants must:

To enter on Instagram participants must:
